**Political Asylum/Immigration Representation Project Gala Celebrates the Work of Pro Bono Attorneys Who Represent Immigrants Seeking Asylum or in Detention**

Hundreds of attorneys will be attending the Political Asylum/Immigration Representation Project (PAIR)'s Annual Gala to honor twelve recipients for their outstanding work in supporting non-citizens, including asylum seekers, individuals in detention, victims of torture and unaccompanied minors. As PAIR Executive Director has noted, "This is a critical time for PAIR and the community to stand together to protect immigrant rights, especially the right to justice and safety." The event will honor supporters, individuals and firms who have demonstrated tireless efforts to demand justice for many immigrants so that they can find a safe haven in the U.S. and rebuild their lives. The gala will also highlight PAIR's legal work, in particular in the detention context; client stories; and keynote Haseena Rahman, a human rights activist from Afghanistan.

PAIR provides free immigration services to indigent asylum seekers and detained immigrants, assuring fairness and access to justice. PAIR has a caseload of over 1,700 active asylum and detention cases each year and represents its clients primarily through a large panel of over 1,500 active pro bono attorneys whom PAIR recruits, trains and mentors. Pro bono attorneys donated over 30,000 hours last year, a value of \$18.7 million worth in donated legal services in the last year to represent PAIR clients.
